Guest Speaker: Wendy Weber, Registered Practical Nurse and Cannabis Educator



Wide use of cannabis became legal in Canada on October 17th and cannabis can now be used recreationally as well as medicinally. This webinar will primarily explore the medicinal uses of cannabis.

Join Wendy Weber from WeedMD, to learn all about the cannabis plant and the history of cannabis as a medicine. Participants will learn the difference between cannabidiol (CBD) and tetrahydrocannabinol (THC) and the ways in which the medicine is administered. Participants will gain an understanding of the positive effects medical

cannabis can have for pain, fibromyalgia, appetite, sleep, etc. for the senior population.

WeedMD has taken an active role in outreach to long-term care homes across Ontario. WeedMD's Medical Director has prescribed cannabis to over 1,000 patients with a myriad of chronic health conditions and has played an active role not only in educating his peers on the uses of medical cannabis but also guiding them with proper dosing and product selection. WeedMD's goal has been to create awareness and by creating awareness, together we can advocate for change.

## OARC Board Update: Consultation with the Hon. Justice Eileen Gillese

The Hon Justice Eileen Gillese and Sharron Cooke

The Public Inquiry into the Safety and Security of Residents in the Long-Term Care Homes System, led by Commissioner, the Hon. Justice E. Gillese is well into the second phase of the process which involves face to face consultations with key groups that will help to shape the content and direction of the recommendations put forth by the Commissioner in a document slated for release in July 2019.

On November 15, the OARC welcomed the Commissioner to an in-person Board meeting in Newmarket. Some Board members and team members attended the Newmarket gathering while others attended through a virtual connection (computer or telephone) from Ottawa, St. Catharines, and Cornwall. In the span of the two-hour consultation, OARC worked to 'paint a picture' for the Commissioner, describing what life in long-term care is truly like. Many Board Members prepared a 2-minute commentary each, speaking on topics such as:

- How did you feel when you moved into LTC?
- What changed in your life when you moved into LTC?
- What does it mean to be vulnerable?
- What does a 'day in the life' of a resident in LTC look like?
- How has the Elizabeth Wettlauffer case affected you?
- What is important for excellent quality of life in LTC and reducing risk of harm?

Justice Gillese immediately connected with OARC's resident leaders and together, the OARC team and the Commissioner shared in candid reflection and commentary on the important themes that were raised. Justice Gillese was receptive, respectful and extremely interested to know the truth from residents' perspective. She acknowledged the important changes that could be implemented, based on her recommendations, to ensure that residents live free from risk of harm.

The Commissioner explained that in her view, the Public Inquiry will shine a light on each corner of the long-term care system, so that the system can begin to be repaired, and recover from what was described as a shattered reputation and loss of public confidence. When asked how she would learn about Culture Change in the long-term care sector she said, "OARC is

our window into a resident's home." We were honored to host Justice Gillese and she expressed her gratitude for the candid exchange.

The final report and recommendations of the Public Inquiry into the Safety and Security of Residents in the Long-Term Care Homes is expected to be released sometime in July 2019.

# OARC presents Resident Centred Home of the Year Award at OLTCA Conference

The Board of Directors, comprised of resident leaders in longterm care homes across Ontario, meets together to adjudicate all entries, resulting in the selection of a winner. # BSO Person-Centred Language Initiative – Report, Tools and Upcoming Webinar

Behavioural Supports Ontario (BSO) worked with an expert panel to create resources to support person-centred language. The <u>23-page report</u> provides background on the project and the panelists (which included OARC's Dee Lender and David Kent). The report breaks down and defines what is meant by "person-centred language" and offers strategies to consider and asks vital questions for organizational and self reflection.

<u>Posters, certificates and an online pledge</u> were created to support LTC home's efforts to adopt appropriate language. Please note that these tools are also available in <u>French here</u>.
