#### Further Restrictions Lifted in Ontario LTC homes

On Monday, February 21st, we welcomed more of the Ministry's projected plans for lifting restrictions in LTC homes including the following:

- Resuming all general visitors 5 years and older who have had at least two COVID-19 vaccine doses (children under 5 years of age would continue to be restricted from entering a long-term care home, except for infants 12 months or younger.)
- Increasing limits on the number of visitors (including caregivers) who may visit a resident at one time to 3.
- Expanding social day absences to all residents regardless of vaccination status.
- Resuming social overnight absences for residents who have had at least three COVID-19 vaccine doses.
- Resuming adult day programs, entertainers and personal care services (where the
  person is not a staff member). Social group activities should remain as small
  groups (i.e., up to 10).

#### Residents Contributing to National Standards

#### **Informing HSO's National LTC Services Standard**

<u>Health Standards Organization (HSO)</u> will be conducting virtual visits with residents of long-term care homes across Canada in the upcoming months to gather information to inform our new <u>National Long-Term Care Services</u> standard and build on what we have heard from over 350 residents so far. HSO would be grateful for the opportunity to organize virtual visits with residents in your network. #### Who is Health Standards Organization (HSO)?

HSO is a global organization that develops evidence-based standards, assessment programs, and quality improvement solutions. HSO is the only Standards Development Organization (SDO) in Canada solely dedicated to health and social services. Affiliated with Accreditation Canada (AC), HSO's standards form the basis of AC's accreditation programs and are used in over 15,000 locations and 38 countries.

#### Why is HSO speaking with residents of long-term care homes?

HSO is currently developing a new *National Long-Term Care Services* standard that will be shaped by the needs and voices of Canada's LTC home residents, workforce, local communities, as well as broader members of the public. Through previous consultation opportunities, HSO has already heard from over 18,000 Canadians about their experiences with and perspectives on long-term care, including over 350 LTC home residents.

HSO wants to engage even more residents, especially those from under-represented groups, to further inform the development of the standard. To do this, HSO will be conducting virtual visits with residents of LTC homes across Canada to gather additional insights and information from them.

HSO is particularly looking to hear from residents living in the following regions: Quebec, British Columbia, New Brunswick, Nova Scotia, Newfoundland and Labrador, Manitoba, and the Territories. In addition, HSO is particularly looking to speak with residents who identify as First Nations, Inuit, or Métis, residents who identify as a visible minority, French-speaking residents, LGBTQ+ residents, younger residents, residents living in rural or remote areas, and residents with visual and/or hearing impairments.

### Public Review Draft of the New CSA Standard Z8004, *Operations and infection prevention and control* is now available

This standard was developed by the CSA Group Technical Subcommittee on Long-term care homes, under the jurisdiction of the Technical Committee on Healthcare Facilities. The attached draft is available for 60-day public review and comment period until **April 11, 2022.** Click here to review.
