DID YOU KNOW

OARC's understanding of the needs of Ontario's LTC Residents'
Councils was significantly enhanced by our province-wide
environmental scan that we conducted in the summer of 2022,
yielding over 1,000 responses from LTC residents, Residents'
Council Assistants (team/staff members who support the
Councils), and Administrators. In addition to identifying barriers to
effective functioning of Residents' Councils, our research found
that strengthening Residents' Councils requires ongoing support
and education. OARC is taking steps to meet the diverse and
evolving needs of Residents' Councils and their supporters.



Ministry Update: Ontario Doubles the Number of Long-Term Care Inspectors

On February 24th, the Ontario government announced that 193 new long-term care inspection staff, including 156 new inspectors, have been hired on— doubling the number of inspectors in the field completing on-site inspections and responding to complaints more quickly. OARC looks forward to contributing to the training program for new inspectors and investigators that will be joining the Ministry of Long-Term care.

Regular and ongoing inspections play a role in optimizing care and the quality of living that residents experience in their long-term care (LTC) homes. OARC is pleased that the government has invested in this important accountability measure. Our hope is that the increased number of inspectors will result in regular touch points with Residents' Councils, more Proactive Inspections being performed and sharing of best practices across LTC homes.
