

Dave's Monthly Musing: The Forum

Growing up as I did, in Montreal, Quebec, the 'Forum' was a big part of my life. An historic building, the Forum was across the street from the Atwater Terminal where I caught the Sherbrooke 105 bus to go home. It was also across the street from the Alexis Nihon Complex, consisting of a shopping centre, two office towers and a residential building. Conveniently, it connected to *le Metro...* also known as the subway. It was just always there.

Most of all, the Forum is celebrated as the home of the Montreal Canadiens Hockey Club. It became a hockey 'shrine' when the franchise dominated the sport between 1953 and 1960, winning six Stanley Cups, including five straight. Legends played there... Jean Beliveau, Maurice 'Rocket' Richard, Jacques Plante and Doug Harvey, just to name a few.

My fond memories continue, as I can happily recall the Forum as the venue for my first date with the girl who would be my wife just five short years later. But that's a whole different story...

Looking back in history, there was also a Forum in Ancient Rome. For centuries the 'Forum Romanum' was the centre of day-to-day life, the site of criminal trials, triumphant processions, elections, debates, gladiatorial matches and the nucleus of commercial affairs.

Here at OARC, we have taken this idea of the Forum, and we've updated it for the 21st century, by creating a virtual meeting place for residents living in long-term care homes across Ontario. Using the Zoom platform to connect to <u>our weekly online Forums</u> can be a way to meet new friends and to share concerns and successes. For residents, it's a place where ideas and views on a particular issue can be exchanged and discussed without fear of reprisal or of being judged. Forums are completely resident-led and our weekly conversations are not recorded.

OARC Home Support Insights: Navigating Conflict at RC Meetings



Some of OARC's recent support calls and home visits have involved the thoughtful navigation of Residents' Council dynamics. Part of what makes each home and Council special is the opportunity to hear different perspectives and work together to reach consensus decisions. Occasionally, Residents' Councils might experience conflicts that require some creative problem solving to make meetings more inclusive, respectful, and productive.

OARC recommends that Residents' Council members develop their own **code of conduct**, which can be embedded in the Council's Bylaws. When Councils work together to create a code of conduct and identify the steps that will be taken when it is not followed, the process can be empowering and have beneficial outcomes. Some Councils review their code of conduct annually when Bylaws are updated. The code of conduct can also be printed and displayed in your Residents' Council meeting space, or you might consider laminating copies for easy reference. Having the code readily available, in some cases, might allow the person who is chairing the meeting to confidently redirect perceived disruptions in the moment.

Residents' Council members can also work together to personalize <u>OARC's Opening</u> <u>Guidelines and Closing Remarks</u> as another way to reinforce aspects of your code of conduct by framing your meetings with a respectful message and tone. Some Councils might choose to create their own Mission or Purpose Statement as an additional reminder about what the group stands for/hopes to achieve.

If your Residents' Council experiences a reoccurring conflict between members who are expressing personal or oppositional viewpoints, it can be helpful to take the time to learn more about each member's strengths, areas of interest and/or concern as a first step. These conversations can take place between residents and the Council Assistant in advance or between meetings and can help strengthen relationships and establish trust.

It's important to note that some residents may be speaking up and expressing themselves at Council meetings for other reasons. Councils may consider partnering with their home's Social Worker or a member of their Behavioural Supports Ontario (BSO) team (if available) to discuss strategies that support cohesive living, as some residents may be living with a mental health diagnosis or changing cognitive abilities. Having a better understanding of what resident peers may be experiencing can also foster more compassionate and caring relationships and promote inclusive Councils.

When residents feel they have an opportunity to contribute during a Council meeting in a way that is meaningful to them (for example, reading your Council's financial/treasury

report, sharing ideas for programs and outings, or discussing one of the residents' rights etc.), they are more likely to feel valued, validated, and heard.

It's important to allow everyone the opportunity to speak and share during meetings, but it's also important to follow your Council's set agenda. Sometimes allotting an amount of time to each agenda item (and sticking to it!) can keep meetings on track.

Updates from Our Ministry of Long-Term Care (LTC)

OARC encourages LTC teams to explore ways to share the following updates (and how they relate to activities in the LTC home) with Residents' Councils to support transparency and open communication. Distributing this newsletter can help to start the conversation.

February 21, 2024: Message from the Minister of Long-Term Care (LTC) - Fiscal Year Three (2023-24) LTC Staffing Increase Funding Update

The LTC Staffing Increase funding is intended for the purpose of sustaining or increasing the direct care time provided by nurses, personal support workers (PSWs) and allied health professionals (AHPs) to residents. Eligible expenses include salaries, wages, benefits and hours for both new and existing direct care staff. Our government continues to work towards a province-wide average target of four hours of daily direct care by March 31, 2025.

Per this latest update, effective March 1, 2024, eligible LTC home licensees will receive an adjustment to the funding provided for staffing investments aimed at increasing direct hours of care. Access the supporting documents for this update below:

Residents' Council members may consider asking their Administrator about whether their home is amongst those eligible to receive the infusion of funds noted above. In addition to care and clinical services, residents might be interested in learning about other types of allied health providers (e.g. social work, recreation) that have been supported through this funding.

February 12, 2024: Memo from Assistant Deputy Minister, Policy, Sean Court - Continuous Quality Improvement Initiative and Resident and Family/Caregiver Experience Survey

Reminder to LTC Licensees about their obligations related to the continuous quality improvement initiative and the resident and family/caregiver experience surveys in the Fixing Long-Term Care Act, 2021 and the Regulation. Highlights include:

Resident and Family/Caregiver Experience Survey

- Survey executed at least annually to measure the resident and family/caregiver experience with the home and the care, services, programs and goods provided
- The licensee must seek the advice of the Residents' Council and Family Council (if any) in carrying out the survey and acting on its results.

The continuous quality improvement (CQI) initiative Every licensee must:

• Establish an interdisciplinary quality improvement committee, which must include at least one member from the Residents' Council and Family Council (if any);

- Ensure the home's CQI initiative is coordinated by a designated lead (who is a member of the home's staff);
- Prepare a report on the CQI initiative for the home each fiscal year;
- Publish the CQI initiative report on the home's website and share a copy of the report with the Residents' Council and Family Council (if any);
- Maintain a record of the names of the people who participated in the evaluations of improvements in the CQI report.

February 9, 2024: Memo from Assistant Deputy Minister, Policy, Sean Court – Public consultations on proposed amendments to Ontario Regulation 246/22 under the Fixing Long-Term Care Act, 2021

The Ministry is proposing amendments to the long-term care Regulations in the areas of staffing, pandemic recovery and stabilization, and clarifying the technical amendments. A detailed summary of the proposed amendments can be accessed on the Ontario Regulatory Registry, with the opportunity for public comment until March 10, 2024.

OARC is pleased to have been amongst the LTC stakeholder groups consulted on the proposed amendments, including the proposed requirement for homes to involve Residents' Councils and Family Councils in the review of existing visitor policies and any future revisions, and the removal of the minimum number of instructional hours (currently 100) for Administrators' training. We look forward to sharing future updates regarding the outcomes of these proposed changes.
