March is Nutrition Month: Small bites of inspiration from Resident Leaders

On March 3rd, OARC Resident Leader Gale facilitated a Food-Focused Resident Forum on the hot topic of the Dining Room Experience in LTC. Residents discussed some of the challenges and opportunities in this area. Some of the promising practises we heard about were:

- Introducing sound-absorbing materials to the dining area, such as tablecloths and drapery
- Working with Nursing and Administration to ensure that medical procedures (such as insulin injections, eye/ear drop administration, swabs and dressing changes) are not taking place in the dining room
- Using "real" tableware instead of plastic or melamine wherever possible, and providing cups and saucers instead of mugs based on resident wishes
- Working with Programs/Recreation department to enhance dining experience through use of décor, music and celebrating special occasions
- Working with Programs/Recreation department on food related programming, such as cooking clubs, socials, and dine-in clubs to provide opportunities outside of set mealtimes to enjoy food and drink

OARC Resident Leaders recommend that Residents' Councils incorporate a Food Committee/Focussed Food Discussion into their monthly Council meetings and have the Dietary Manager/Food Services Supervisor as an invited guest for that portion of the

meeting. You might also consider forming a separate Food Committee that provides a report at the Residents' Council meeting. Implementing this practice allows your home's Dietary team to frequently hear directly from residents and provides an opportunity for residents and Dietary to work collaboratively to improve quality.

OARC Resident Leaders Informing National Standards

On March 16, a group of OARC's Resident Leaders participated in a virtual consultation with the *Health Standards Organization*. Residents were invited to share their pandemic experiences and suggest ways that their experiences as residents living in LTC could be improved moving forward. This feedback will be brought back to the National Standard of Canada working group. OARC will also be submitting feedback as part of the public review of the proposed standards.

We look forward to contributing to the review process of the <u>CSA standards</u> in the coming weeks.

HSO Virtual Visits with Residents Extended Until End of April <u>Health Standards Organization (HSO)</u> will be conducting virtual visits with residents of long-term care homes across Canada until the end of April 2022. HSO is currently developing a new <u>National Long-Term Care Services standard</u> that will be shaped by the needs and voices of Canada's LTC home residents, workforce, local communities, as well as broader members of the public. Through previous consultation opportunities, HSO has already heard from over 18,000 Canadians about their experiences with and perspectives on long-term care, including over 350 LTC home residents.
