Keeping Residents Informed & Connected with Government

On Friday, June 23, the Ministry of Long-Term Care (MLTC) announced changes in COVID-19 measures, including masking and infection prevention and control (IPAC) requirements. These changes, outlined in a memo from Assistant Deputy Minister, Jeff Butler, have been made following consultation with the Office of the Chief Medical Officer of Health and are expected to be implemented by this Friday, June 30th.

An updated <u>"What Residents Can Expect"</u> handout and <u>Frequently Asked Questions</u> resource highlighting the latest changes were included as part of the Ministry's sector communications. OARC recommends printing and posting these materials in addition to providing verbal updates to residents in your home. Residents' Council Week is just a few months away! What is your Residents' Council planning for this annual week of recognition?



The Ontario Provincial Police and GTA police services are jointly conducting an investigation into Emergency Grandparent Scams, which target elderly persons throughout Canada. According to a communication released by the Ministry of Long-Term Care (MLTC) on June 6th, the majority of the victims of recent phone scams are Ontario residents. The MLTC is partnering with the OPP and the Ministry of Health to share the attached prevention materials with Ontario long-term care homes and their residents.

News from the Ministry of Long-Term Care

June 22, 2023: The Ontario government is providing \$16.5 million to provide education to 600 new personal support workers across the province. Humber College's accelerated education, Learn and Earn Accelerated Program for Personal Support Workers in Long-Term Care (LEAP LTC) will offer existing long-term care team members the opportunity to become PSWs.

Participate in the GERAS Landmark Study

Canadian long-term care (LTC) homes are invited to participate in a research study to help prevent hip fractures in residents (age 65+) and improve their quality of life. This study opportunity has



been shared by the <u>GERAS Centre for Aging Research</u>, part of Hamilton Health Sciences and affiliated with McMaster University.

Why is this study being done? Together with our partners in LTC, we are looking to reduce the devastating impact of fractures (suffering, pain and reduced quality of life) by integrating routine assessment and multifactorial osteoporosis management within LTC homes.

What does this research involve? Over a one-year period, LTC teams will participate in an educational meeting describing the PREVENT model, the fracture prevention recommendations in LTC and our fracture prevention toolkit.

Why is it important? This is the first randomized controlled trial in LTC using a model to examine fractures which may be used across Canada with potential lifesaving and healthcare cost-saving implications.
