#### OARC bids farewell to Murray Woodcock, OARC Board Director







With sadness and gratitude, we share the news of the passing of Murray Woodcock, Director on the Board of Directors with OARC. Murray joined OARC in 2020. His reason for pursuing the opportunity was clear: he wanted to make a difference in how life is experienced in long-term care (LTC) homes. He was not interested in long-winded meetings and political etiquette. He wanted change and he wanted it NOW. He knew the world of LTC first as a family member; loving husband of his wife who lived with dementia in an LTC home. Then he lived alongside her as a co-resident prior to her passing. He knew what LTC involved from the family perspective and from the resident perspective.

Murray was proud of his LTC home. He respected the team members and management in his home. He was the President of his Residents' Council and advocated loudly, strongly and sternly for the improved quality of living in long-term care; specifically, he was a champion for better food and a better dining experience. Murray was persistent, tenacious and passionate about speaking with the Ministry of Long-term Care and corporate leaders about the need for a raise in the food budget for LTC residents. He spoke for years about the need for an increase and in 2023 he was acknowledged by the (then) Minister of LTC, Honourable Paul Calandra as being the catalyst for the increase that was realized that year.

Murray was known for his powerful statement – "Residents' Councils are the life blood of the home!" Murray understood the dynamic and powerful influence that Residents' Councils have in making suggestions and prompting change in every LTC home.

With OARC, Murray was a steadfast advocate for 'getting work done' and for 'always remembering the resident.' In Board and Committee meetings we could rely on his sage wisdom in saying, "Whatever we do, we must always do it keeping residents in mind."

This is the tough part of the work that OARC is privileged to do. When we work so closely with resident leaders and then have to say goodbye, it hurts to the core. May Murray's memory, advocacy and passion for a better quality of life for ALL RESIDENTS in LTC homes live forever!

OARC is indebted to Murray Woodcock. He led well. He advocated well. He kept OARC grounded and focused on what truly matters. He was a gentleman and a passionate leader. He passed at his LTC home peacefully, at the age of 93. May he rest in peace.

#### **OARC Governance Update**

OARC is governed by a volunteer Board of Directors, several of whom are residents living in LTC homes across Ontario. Every June, OARC holds its Annual General Meeting (AGM), the mandatory gathering of Directors and executive leadership for the Association. ### **Updates from Our Ministry of Long-Term Care**

#### June 6, 2024: Ontario Welcomes a new Minister of Long-Term Care

Minister Kusendova-Bashta was previously the Parliamentary Assistant to the Minister of Long-Term Care and the Minister for Seniors and Accessibility. She has served as a member of the Legislative Assembly of Ontario since 2018 and is MPP for Mississauga Centre. Minister Kusendova-Bashta is also a registered nurse.

The OARC team had the opportunity to speak briefly with Minister Kusendova-Bashta shortly after taking on her new role and we were encouraged by her enthusiasm and commitment. In our short time together, she mentioned how vital it was to hear resident voices and to connect directly with residents during her many home visits.

OARC looks forward to getting to know our new Minister in the coming months and working together to advance our shared goal of enhancing the resident experience and quality of living in Ontario long-term care homes. We would like to thank our former Minister, Stan Cho, for his time and contributions to our sector. # June 19, 2024: <u>Air Conditioning Requirement Reminder and Heat Related Illness</u> Prevention and Management Plans

Kelly McAslan, Assistant Deputy Minister, Long-Term Care Operations Division circulated a memo to <u>long-term care licensees</u> as a reminder to implement heat-related illness prevention and management plans. An accompanying <u>fact sheet</u> describes amendments to the air conditioning requirements that came into effect on May 1, 2024.

#### June 19, 2024: 2024-2025 Rate Reduction Application Forms Now Available

Rate Reduction application forms for the 2024-25 program cycle are now available. Long-term care team members will be available to assist residents seeking to apply for an annual Rate Reduction. #### June 24, 2024: <u>Designation of Placement Coordinator</u>

Deputy Minister Melissa Thomson released a <u>memo to the sector</u> announcing the amalgamation of the 14 Local Health Integration Networks, operating as Home and Community Care Support Services (HCCSS), into a new service organization called Ontario Health atHome. This new organization has been designated as the new placement coordinator for long-term care homes under the *Fixing Long-Term Care Act, 2021*, although these changes (effective June 28<sup>th</sup>) are not anticipated to impact the long-term care placement process.

# **OARC June Engagement Highlights**





On June 13, OARC's Executive
Director Dee Tripp had the
opportunity to meet Canada's
Minister of Labour and Seniors
Honourable Seamus O'Regan Jr.
The Canadian Club hosted a
luncheon where Minister
O'Regan was invited to share his
plans for and views of Seniors'

care across Canada. The themes of his message were dignity, the power of listening, and the universal inescapable fact that care and caring is what links every human being together. All of us were cared for and most of us will require some sort of care as we live our lives and grow older. He announced that he is about to convene a National Advisory table to advise on issues and solutions related to provision of care (caregiving) in Canada.

Dee spoke with Minister O'Regan and a member of his team about OARC's role in the LTC sector, the unique position Ontario LTC homes have with the mandated existence of Residents' Councils in LTC homes, and the fact that OARC is unique in mandate to all of Canada. In fact, Dee advocated for a seat at the table to advise on matters that are important to residents living in LTC homes.

#### **REAL Member Home Spotlight: Rainycrest Long-Term Care Home**

OARC Resident Leader Gary Strickland, and his home team at Rainycrest Long-Term Care Home in Fort Frances, Ontario, were extra busy in the month of June. In addition to running the home's tuck shop, Gary regularly rolls up his sleeves to plan and support activities in the home that enrich the lives of his co-residents.



When a family emergency resulted in the last-minute cancellation of the scheduled Pow Wow and Smudging Ceremony on June 21<sup>st</sup>, Gary and his team were quick on their feet, coming up with an alternative program for Indigenous Peoples Day. Reflecting on the experience, Gary shared: "As a fill in, I was asked to make Bannock [a form of bread], which I love doing. Me and Garrick, an Activation worker, made 3 large Bannocks to

share with residents in the home. Native Residents were invited to watch me prepare this traditional food. I spoke in my Oji-Cree language, explaining what I was doing..." Gary was encouraged by the positive responses he received from all the residents in his home that sampled the Bannock – "everyone loved it!" He was proud to see how this impromptu activity was able to bring together the residents and team members at Rainycrest to learn and connect with Indigenous culture and traditions.

Back for a second year at Rainycrest was the popular Senior Prom! This year's theme was "the Roaring 20's" with black and gold home décor and dress code was a real hit!
