

Remembering David W. Kent, OARC Vice President September 8, 1938 - September 16, 2020



David Kent was an important and influential contributor to Ontario Association of Residents' Councils and a personal mentor. David began his tenure with OARC in the summer of 2016. I remember my first meeting with David. When I explained who OARC was and what he would be doing as a Board Member, he replied, "I don't know. I'm a busy man!"

He taught courses at his home, the Village of Erin Meadows, he was involved in many projects with management, he had an active social life and enjoyed frequent visits with his wife Linda (married for almost 60 years), son, daughter and grandchildren.

David was an inspiration to the thousands of people who have heard him speak about culture change over the past few years. He spoke at Pioneer Network Conferences, Schlegel Villages Team and strategic planning meetings, OLTCAs conferences, and more. (See David speaking about his personal journey with long-term care

David represented OARC well, contributing in significant ways to various groups, Committees and consultations with researchers, Behaviour Supports Ontario and the Ministry of Long-Term Care and Health Quality Ontario. He was aware of the importance and power of language and insisted that we abolish the phrase 'staff member' and use 'team member'. I can hear him reprimanding me in my head whenever I slip up and revert back to the word 'staff'. David served as OARC's Vice President and Chair of the Board Development Committee for the past few years.

Even though David is not physically here, it feels as though he's ever present. David's significant impact and leadership challenged the status quo. David challenged me and made me a better leader. We will miss him terribly and will continue to work full steam ahead in honour of our vision – something that rang true for David, "EVERY LTC RESIDENT IN ONTARIO SHAPES THE PLACE THEY CALL HOME." 

Canadian Foundation for Healthcare Improvement – LTC+: Acting on Pandemic Learning Together Program

CFHI have developed the LTC+: Acting on Pandemic Learning Together program to encourage collective learning that can support teams delivering healthcare for older adults in congregate settings – staff [team members], managers, policy makers, residents, family and caregiver partners and others who are all working hard to manage tough situations now, while also trying to look and plan ahead.

The program is based on findings captured in a new report – [Reimagining Care for Older Adults: Next Steps in COVID-19 Response in Long-Term Care and Retirement Homes](#) – and focuses on promising practices in six key areas that have the potential to help organizations prepare for possible future outbreaks, or mitigate their effects:

- Preparation
- Prevention
- People in the workforce
- Pandemic response and surge capacity
- Planning for COVID-19 and non-COVID-19 care
- Presence of family

This program is designed to support long-term care and retirement homes, whether they have experienced a COVID-19 outbreak or not and want to plan and prepare for future outbreaks.
