#### OARC Participates in Canadian Club Forum

On Wednesday October 20<sup>th</sup>, OARC's Executive Director, Dee Tripp (formerly Lender), was honoured to participate in a <u>Canadian Club</u> event in Toronto where the Honourable Minister of Long-Term Care, Rod Phillips was a guest speaker.

Minister Phillips' presentation shared his vision for restoring long-term care. Main messages focused on staffing, care, accountability, enforcement and transparency. OARC remains enthusiastically committed to ongoing conversations with Minister

Phillips personally and with government more broadly as we work together in repairing public perception and creating long-term care homes that are healthy places to live and work.

Murray Woodcock, one of OARC's Directors and resident leader of his long-term care home's Residents' Council was also in attendance, upon the invitation of Rebecca Scott Rawn, Senior Director of Stakeholder Relations and Advocacy for Extendicare. While Minister Phillips had met both Dee and Murray via ZOOM, earlier this year, a face-to-face conversation was very uplifting.

#### OARC Presentation the Highlight in University of Toronto Graduate Course

Dee Tripp (formerly Lender), Executive Director of OARC and Devora Greenspon, REAL Resident Leader Co-Chair, joined Dr. Samir Sinha in an expert panel for a graduate course on Canada's healthcare system and policy at the University of Toronto (UofT) on September 30, 2021.

The course, led by UofT faculty Sara Allin and Dr. Frances Morton-Chang, introduces students, in Health Administration and Health Informatics at the Institute of Health Policy, Management and Evaluation, UofT, to the key issues and trends in Canada's health system and health policy. With over 100 students, this course covers a range of major health policy issues and challenges and equips them with a policy analysis toolkit in order to critically analyse these issues.

The focus of the September 30<sup>th</sup> session was long-term care reform, and the expert panel engaged with the students in dialogue about the impacts of COVID-19 on the long-term care sector, and on residents in long-term care homes. They also drew attention to priorities for reform, as well as some promising practices in the design of long-term care such as the "green house project".

The students unanimously agreed that the expert panel was the highlight of the session, and they provided quotes in an anonymous survey that point in particularly to the powerful and impactful contributions by Devora Greenspon.

#### Residents Inspiring Future Long-Term Care Home Leaders



Melissa and Devora also proudly contributed to the curriculum of the <u>Leadership in Senior Living Program</u>. Enrollment is open for new, existing or emerging leaders in senior care (home care, community programs, retirement living, long-term care).
