Home Visit Travelogue: Discovering Ontario, One Home at a Time



OARC's home support visits continued into the Fall after our Summer adventures. Melissa Matheson, Education and Home Support Facilitator headed to Ottawa to be with the Councils for Residents' Council week. On her way there she stopped into Cornwall, where she met with Dorothy Asselstine, one of OARC's Board Members, who gave her a tour of Sandfield Place Long Term Care home. Unfortunately, her Ottawa visits were cancelled due to a close contact having COVID-19 but will be rescheduled to another time.

During her travels and home visits, Melissa has worked in partnership with residents and team members to explore strategies to help Residents' Councils rebuild, she has delivered Residents' Council 101 education sessions to new members, and she has helped facilitate thoughtful discussions and idea sharing. A recurring theme from her visits has involved supporting homes to better understand and implement Residents' Council Bylaws. Melissa has been able to walk beside a few Councils during their process of creating Bylaws and establishing procedures to



promote stability, cohesion and clarity within the Councils and their homes. Inspiring LTC Leaders – OARC presents at the Advantage Ontario Administrator Leadership Program

On October 26, OARC Resident Leaders, Devora Greenspon and Steven Wenzowski, met with 45 students seeking to further develop their leadership skills (including many aspiring long-term care leaders) enrolled in the <u>Advantage Ontario Administrator</u> <u>Leadership Program. Devora and Steven's passionate contributions</u> helped to infuse the resident perspective into the curriculum through a presentation called, "It All Comes Back to the Residents" which was supported by OARC's Melissa McVie.

In addition to contributing to a pre-recorded *On Demand* training module outlining the role of Administrators in supporting Residents' Council operations, Devora and Steven led the group through several interactive exercises to help them "walk a mile in a resident's shoes." They also shared advice and a list of qualities that residents hope to see modelled by their home's leadership teams – including the importance of active listening, communication, authentic engagement and follow-through. City of Toronto Residents' Summit 2022

On September 28th, OARC was invited to participate in the City of Toronto's Residents' Summit. The annual event, hosted by Toronto Seniors Services and Long-Term Care, is normally held in person at one of the City's ten owned and operated long-term care homes. Due to the ongoing COVID-19 pandemic, this year's Summit was hosted virtually, which allowed more residents and team members to participate. The session started with a presentation from OARC on the Fixing Long-Term Care Act, 2021, and the rights and responsibilities awarded to residents and Residents' Councils in the new Act. The presentation was followed by a lively question and answer session, where residents shared some of the challenges they have experienced with influencing positive change in their homes. The event concluded with homes sharing some of the innovative and engaging activities and programs that are available to City of Toronto long-term care home residents. 
OARC's Resident Expert Advisors and Leaders (REAL) Group is Expanding

The Institute for Safe Medication Practices Canada (ISMP Canada) is pleased to announce that the *Strengthening Medication Safety in Long-Term Care initiative* is moving into an exciting NEW phase! ISMP is now launching up to **100** <u>Trailblazer Homes</u> with the tools, facilitation, and coaching that have successfully

supported the great medication safety work of the Champion Homes over the past year. The **goal** of the Strengthening Medication Safety in Long-Term Care initiative is to reduce harm associated with medication management errors within long-term care (LTC) in Ontario. This is a 3-year initiative funded by the Ontario Ministry of Long-Term Care. OARC Resident Leader/REAL member, Les Froats, took part in ISMP's first phase of the Strengthening Medication Safety in Long-Term Care Initiative while living in 1 of 10 Champion homes involved with the project. Reflecting on his experience, Les shared, "I have enjoyed getting to know about pills and how they're handled, and I think everyone should get to know how. Every home should be learning this."
