


York University Students Creating Education Sessions with Residents!

For the first time ever, OARC's *Through Our Eyes: Bringing the Residents' Bill of Rights Alive* program became the basis for a unique and powerful student placement. The program is designed to link a team member and resident together in the co-creation of education on the Residents' Bill of Rights. Three months ago, Spencer House, a long-term care home in Orillia, managed by Sienna Senior Living and home to 160 people, welcomed three York University nursing students who readily embarked on the creation of an education session for team members. Each student was partnered with a resident and together, through the course of several in person meetings, created and delivered their respective session, from the residents' perspective.

Dee Lender, Executive Director of OARC, was thrilled to attend all 3 sessions last week. Each session was unique because the varied personal stories, topics, approaches and delivery methods. All were powerful! The students shared with Dee that the placement experience was 'the best', was 'awesome and inspiring' and relevant to their learning. Each resident shared with Dee that they truly enjoyed building personal relationships with 'their student' and they didn't want the experience to end. Dee witnessed the effects of this resident-centred education as she saw team members experience an emotional reaction to what they were hearing. Several team members attended more than one session and commented on how valuable the experience was to them.

A very special thanks to RNAO (Registered Nurses Association of Ontario) regional coordinator Freda Poirier who advocated for this incredible learning opportunity in the home, and to the management team of Spencer House who embraced the project without reservation. Thanks also to the students themselves who demonstrated their commitment to building authentic relationships with each of the residents they worked with!

NEW OARC Fact Sheet: <u>Residents' Councils and Strengths-Based</u> Approaches



OARC's newest Fact Sheet emphasizes a strengths-based approach when leading and supporting Residents' Councils in long-term care. This approach supports Residents' Council to be more inclusive and focuses on what residents CAN do.

Using a person-centred, strength-based approach in our interactions with others involves focusing on the qualities that make each person special. Residents living in long-term care possess important skills and strengths that may help to bolster Residents' Council operations. A resident's social history, including former roles and occupations as well as current hobbies and interests, may assist to engage residents in ways that are meaningful to them. For example: some residents are comfortable speaking out loud, leading or addressing a crowd, while others prefer to observe, write or record information. Some residents are very social and outgoing, making them natural connectors, helping to bring residents together or spread the word about Council meetings and events. Some residents may have creative ideas for fundraising while others prefer to contribute "behind the scenes" and count the money after an event.

We've listed a few <u>enabling practises</u> below to help you apply the concepts from our <u>NEW Fact</u> <u>Sheet</u>. Ask/encourage a resident to:

- Create a poster to help promote an upcoming Residents' Council meeting/fundraiser
- Assist you to create a draft RC brochure to present at a future RC meeting (see OARC template)
- Set up the RC meeting space with you
- Roll coins or count money with you after a fundraiser event
- Greet residents as they arrive at the RC meeting and/or hand out agendas
- Pull a resident right out of a hat, or pick a number between 1-27 that corresponds with a resident right during the meeting
- Read something aloud (opening/closing guidelines, Residents' Bill of Rights, treasury report etc.)
- Accompany you to post approved meeting minutes on RC information board or on each floor
- Oversee a bake sale table or silent auction, or assist with specific duties for a RC event/fundraiser (with or without support from RCA)
- Help prepare (and deliver) a welcome card or gift for a new resident (if no formalized welcoming committee is in place)
- Invite a new resident to attend their first Residents' Council meeting (or ask them to accompany you to do this)
- Consider taking on a RC leadership role, such as a home area/floor representative

OARC Speaks at Advocacy Centre for the Elderly (ACE) Annual General Meeting

Jane Meadus, lawyer with ACE invited Dee Lender, Executive Director of OARC to speak at their meeting, giving the 'client's account' of the work done through ACE during the Public Inquiry into the Safety and Security of Residents in the LTC Home System. Jane, along with Suzan Fraser, Council with Fraser Advocacy, represented OARC over the two year period of the Inquiry.

In Dee's remarks, she explained the emotional and psychological pain that residents expressed as a result of the crimes committed, and the reinforcement of the vulnerability residents live with each day. Dee stressed the importance of a shift in culture that is needed, one that places residents at the centre of all decisions and strengthens LTC homes' ability to provide care that is respectful and dignified. When people are objectified, in the absence of respect and dignity, the door opens for abuse and neglect.

OARC remains indebted to the excellent, thoughtful and respectful work performed by Jane and Suzan in representing the voice of residents during the Inquiry process.
