#### JOINT MESSAGE FROM OARC BOARD CHAIR AND EXECUTIVE DIRECTOR

The vision of Ontario Association of Residents' Councils (OARC) is that every long-term care (LTC) resident in Ontario shapes the place they call home.

The impact of this statement, this aspiration, has never been more relevant. While the world has lived through the COVID-19 pandemic and is starting to move forward, the negative impact, trauma, and lasting consequences of this collective experience has disproportionately and negatively affected the LTC sector. The work of changing the culture of LTC, through, among other strategies, effective Residents' Councils, has been challenged as a result of the heavy focus on infection prevention and control, prolonged periods of isolation, the human resources crisis, social disengagement, communication breakdown, fear, panic, and the death of thousands of people living in LTC.

Residents' Council operations have been stifled by significant barriers to effectiveness these past two-and-a-half years. The form and function of Residents' Councils have been challenged like never before. The time is now to discover new ways and to re-envision existing ways that residents can shape the place they call home, including, but not limited to re-invigorated and active Residents' Councils. This is one of the ways to bring to life the true meaning of the principle of citizenship. An active, well-functioning Residents' Council, with each resident participating actively in the life of the LTC home, are among the most critical ways residents bring self-determination and citizenship to life.

Throughout this experience, OARC has focused our efforts and made investments into OARC's four strategic priorities: mobilizing Residents' Councils, investing in strategic partnerships, engaging in targeted stakeholder education and building organizational capacity and sustainability.

We have increased our advocacy efforts as well as the number of engagements in stakeholder groups, working in partnership to elevate both issues and opportunities directly to our government to inform policy and change practices. The OARC team and Resident Leaders have helped to highlight the need for enhanced communication from the top down, and the need to find a balance between virus management and the psychosocial well-being of residents. We continue to infuse every conversation and consultation with examples of resident voice and lived experience, reminding others that consideration for residents must be at the very core of all decisions, at every level.

These efforts have been supported and encouraged by the OARC Board of Directors, which provides governance oversight and strategic leadership to the critical work of the organization.

The years 2021 and 2022 to-date have been formative and productive for the Board. At the outset of its mandate in June 2021, the newly installed and expanded Board of Directors committed to striving for an even greater collective impact of OARC's vision and mandate. With deep admiration, appreciation and respect for each member of the previous Board of Directors, the new Board committed to building upon the four decades of ground-breaking and resident-focused work of the organization. The new Directors represent expertise and knowledge from fields across the LTC spectrum and beyond, including Resident Leaders.

In order to ensure that the voice of residents who live in Ontario's LTC homes, is not only heard but heeded, an advisory group of Resident Leaders was created, called the REAL Group — Resident Expert Advisors and Leaders. This group provides input and advice related to OARC's program activities, they co-develop and deliver presentations to target audiences and identify new opportunities to help OARC be more responsive and impactful. The contributions of REAL members, borne of experience and wisdom, is central to everything OARC does.

The Board supported a number of significant operational changes to enable a solid foundation upon which to further enhance the ability of OARC to fulfill our mandate, including, the expansion of the OARC team to allow it, among many priorities, to continue responding to the ever-growing educational and resource needs of Residents' Councils across the province; and identifying and pursuing research grant opportunities to ensure that OARC is always at the forefront of leading practices and evolving thinking.

New Board Committees were created with a wide membership, including Board Directors, OARC team members and external experts with subject matter knowledge. Each Committee supports and informs the operational work of the OARC team.

So many of our efforts are focused on enabling, encouraging and supporting much needed and permanent culture change in LTC. True to the spirit of the Past Chair of the Board, the late Sharron Cooke who passed away on August 28th of this year, the key to effective and lasting change is not to fight the old, but to build the new.

We all feel privileged and honoured to be able to contribute our collective efforts, expertise and deep commitment to continue the critical work of the OARC team and Board of Directors.



#### **WHO WE ARE**

We, the Ontario Association of Residents' Councils (OARC), are a not-for profit association, created in 1981, representing the voice of over 100,000 residents annually in long-term care (LTC) homes in Ontario.

Every LTC home, by law, must have a Residents' Council, a formalized forum for residents to come together to provide peer to peer support and present consensus decisions, opinions and requests to management to action improved quality of living for all residents.

We encourage, support and assist residents in:

- Forming and operating effective Councils
- Becoming active participants in the management of their homes and communities
- Sharing and consolidating ideas and promoting policies that improve quality of living
- Educating the community about issues they face

# **Academic Partnerships**



#### **OARC FINANCIAL REPORT**






# In Loving Memory
