ANNOUNCEMENT: Ministry of Long-Term Care Investment into OARC

Dear Residents and Team Members,

In recognition of the impact that the Ontario Association of Residents' Councils (OARC) has in our long-term care (LTC) sector through leveraging the resident voice, supporting Residents' Councils and consulting with government working groups and committees, the Ministry of LTC announced yesterday that that they will be increasing the funding to OARC by almost 50%. Earlier this week, on Monday July 19th, the Honourable Minister of LTC, Rod Phillips attended an OARC Board meeting to personally thank OARC and share the announcement of increased funding. During the meeting he heard directly from resident leaders who brought several requests forward including:

- increasing the food budget for residents in LTC
- ensuring PSWs receive a living wage
- safeguarding the focus of the free PSW training such that many PSWs enter the LTC system

Minister Phillips articulated his commitment to understand more fully, the lived experience of residents and take corrective measures. OARC looks forward to continued discussions with the Minister and his team as we work together to "fix the system."

"Minister Phillips, on behalf of Residents' Councils and the thousands of people who bring those Councils to life & effectiveness, THANK YOU for your announcement today. As previously noted, the LTC system – which includes OARC – has been under resourced and under valued for a very long time. We are excited to work at the systemic level with your team, at the level of broad public awareness and at the home level, supporting Residents' Councils and the people who help them to function!"
