Join us For a Resident Information Session on April 18th Ministry of Long-Term Care Update on Regulation Changes

Dear Residents and Residents' Council Supporters,

Earlier this afternoon, our government released communications to long-term care operators (licensees) providing information about changes to <u>Ontario</u> <u>Regulation 246/22</u> under the <u>Fixing Long-Term Care Act, 2021</u> that will come into effect on April 11, 2023.
